- Mr. Jewell noted that he, along with representatives of Sturgeon School Division, attended a meeting with Morinville Town Council, where the following items were reviewed:
- Status of a school building site (15 to 20 acres)
 - Confirmed that Sturgeon School Division will not receive any design and development funding (\$750,000) until we are given a school site by the Town of Morinville
 - Advised that Sturgeon School Division is encountering difficulties in obtaining a Development Permit for the addition of six Modular Classrooms at Morinville Public School after discussions with respect to parking spaces, Town Administration advised that Sturgeon School Division needed to file a Development Permit application and they would attempt to facilitate a speedy process.
 - Sturgeon School Division requested the Town’s assistance in trying to obtain parking at the Parish Hall site.
 - Sturgeon School Division also requested the Town to work together to initiate a Communication Plan to the parents of Morinville Public School on an urgent basis.
 - Advised that Sturgeon School Division will require Board direction with respect to a formal request for a suitable (15 to 20 acres) School site in Morinville since it appears that the South Glens site will not occur within a reasonable time.
