## What Interested Candidates Need to Know

Through the *Education Act*, the Minister of Education assigns, to the Sturgeon Public School Division Board of Trustees (the Board), the responsibility of providing a public education system that organizes and operates in the best interests of students and their parents or guardians. In Alberta, school boards are considered statutory corporations empowered by the provincial government to govern local education. This structure reflects the principle that decisions made at the community-level are more effective and responsive to location needs.

### Vision, Mission, and Values

#### Vision

Sturgeon Public Schools: where, through a well-rounded education, students are motivated and supported to pursue their unique path to future success.

#### Mission

Working together as a team of trustees, parents, community, staff, and students, we create safe, respectful, and collaborative learning environments where students are prepared to meet, and excel at, the challenges presented by the global community.

#### Values

- **Excellence in teaching:** We know that magic can happen when students are engaged, excited and feel connected to their learning and their teachers.
- **Shared responsibility:** We all have an important part to play in the education process. Working together, we strive for excellence so we can build a stronger future for us all.
- **Mutual respect:** Students, staff and parents all deserve to be treated with respect. By fostering reciprocal respect within our system, we will all be able to reach our full potential.
- **Belonging:** Students must be able to learn in healthy environments where they feel safe; have strong connections; are free from bullying; and where their physical, intellectual, and emotional needs are met. We are a school division and a family.
- **Learning choices:** One size does not fit all. We recognize that to prepare students for their futures, we must meet their diverse needs along the way.
- **Communication:** To do the challenging work of educating the next generation, we must keep the communication channels open. We value open, honest, and timely communications.

The governance of Sturgeon Public Schools is entrusted to seven elected trustees, who are committed to setting strategic policy directions for the Division and serving as representatives of the community.

The Board of Trustees values and actively seeks the perspectives of stakeholders. We invite participation and feedback at board meetings, through involvement in school councils, and during the formulation and planning of our policies.

In their dedicated roles, each trustee plays an integral part in Division committees, enhancing the efficacy and reach of the Board's work.

### Role of a Trustee

The role of the trustee is to contribute to the Board as it carries out its mandate to achieve its Vision, Mission and Values. The oath of office taken, or affirmation made by each trustee when assuming the role binds that person to work diligently and faithfully in the cause of public education.

The board of Trustees is committed to Public Education and its Trustee Members shall conduct themselves ethically and responsibly in carrying out the duties that they have been elected to fulfill. It is expected that all interactions related to the operations of the Board is Characterized by mutual respect, which acknowledges the dignity and worth of all individuals.

Their responsibilities include setting priorities for the school system based on available resources, adopting an annual budget, developing policies to guide administration, and advocating to ensure education remains a public priority.

In Alberta, citizens elect school boards to act for the legislature in their local schools and communities.

Alberta School boards help shape the future of local communities by governing the education of young people. The provincial government, through the Minister of Education, grants school boards the authority to make decisions regarding the direction and quality of local public education. Accountability to the public is entrenched through the election of local school board trustees every four years.

Sturgeon Public Schools Board of Trustees is responsible for outstanding work that benefits our schools and communities. Our Trustees act as advocates for students, stewards of public funds and connectors between the community and the school division. Trustees work collaboratively as part of the corporate entity of a school board to ensure students receive a high-quality education that reflects the values and needs of the communities served. ## Nomination and Election Guide

**Please note:** This is an information manual only and has no legislative sanction. For certainty, please refer to the [Local Authorities Election Act](#).

### Nomination Day

For all 7 of the Sturgeon Public School Division wards, Nomination Day is **Monday, September 22, 2025**.

The nomination period runs from **January 1, 2025, through to noon on Nomination Day**. Candidates wishing to submit their completed nomination package prior to Nomination Day will contact the Returning Officer by calling **780-939-4341** or emailing [corporate.services@sturgeon.ab.ca](mailto:corporate.services@sturgeon.ab.ca) to make an appointment.

On Nomination Day, papers will be received by the Returning Officer between the following times at:

### Nomination papers may be handed in by any person:

- Nomination Paper and Candidate's Acceptance form (**Form 4**)
- Candidate Financial Information form (**Form 5**)
- Submit a current criminal record check from a police service in Alberta
  - Must include results of both local and national records including charges and convictions
  - Must be within 90 calendar days prior to the date the nomination is submitted

At any time after **12:00 noon** on nomination day, nomination papers may be examined by an elector during regular business hours and in the presence of the Returning Officer.

Every nomination must be accompanied by a **deposit of \$25.00**. Cash, bank drafts and money orders are acceptable forms of payment. Credit and debit card payments will also be accepted for the duration of the 2025 election year. Personal Cheques will not be accepted.

Should candidates wish to withdraw their nomination, they may do so, in writing, in person until the nomination period closes at **noon on Nomination Day, September 22, 2025**.

### Qualification of Candidates

To be nominated as a candidate in the school board election under [the Local Authorities Election Act](#), a person must be eligible under Sections 21 and 47 of the Local Authorities Election Act and Sections 4(4) and 74 of the [Education Act](#) (if applicable) to be elected to the office, and not otherwise disqualified under Section 22 or 23 of the Local Authorities Election Act.

### Voting Requirements

In accordance with Section 47 of the [Local Authorities Election Act](#), a person must:

1. Be at least 18 years old
2. Be a Canadian citizen
3. Have resided in Alberta for the 6 consecutive months immediately preceding election day and the person's place of residence is located in the area on election day, and

In accordance with Section 74 of the [Education Act](#), where a separate school division is established:

- An individual residing within the boundaries of the separate school division is a resident of the separated school division if the individual declares that the individual is of the same faith as those who established the separate school division, where Protestant or Roman Catholic.
- Notwithstanding the [Local Authorities Election Act](#), a resident of a separate school division is eligible to vote for a trustee of the board of either the public school division or the separate school division in which the person's residence is located, but not both.

### Advanced Vote

Advance Vote dates are permitted as alternative dates for voting. You do not have to declare any special circumstances to be permitted to vote at the Advance Vote. Each voter must present the required voter identification. Any person who does not comply with the legislation will not be allowed to vote.

Advance voting will be held at the following times and locations.

### Special Ballot (Mail-In Voting)

Voters who are unable to vote at their designated advance vote or Election Day voting station, may apply to vote by special (mail-in) ballot.

## Voting Station Recount

In accordance with **Section 98** of the [Local Authorities Election Act](#), the returning Officer may make a recount of the votes cast at one or more voting stations if the returning officer deems grounds are considered reasonable to require a recount; or the returning officer receives an application for a recount in accordance with the Act. An application for a recount may be made during the 44 hours immediately following the closing of the voting stations. The deadline to apply for a recount under **Section 98(4)** is 4:00 PM, Wednesday, October 22, 2025.
